- Use only dry **natural wood** that has not been treated, or **EN-Plus certified pellets**. **Never** burn **waste** (not even paper, cardboard, coloured magazines, plastic, styrofoam, treated wood, furniture) as they release toxic substances (such as formaldehyde and dioxin). Use the appropriate firelighter cubes in order to light the systems.



- Do the **maintenance** of the system **once or twice a year** (see UNI 10683) and the maintenance of the chimney once a year: a clean chimney is safe and **prevents the risk of fire and backflow of harmful fumes** into the house. It allows saving and is environment-friendly.



- **Contact** only **installers and maintenance technicians certified** by the Chamber of Commerce (MD 37/2008) that, on completion, issue a Declaration of Conformity or a Maintenance Report. **Do-it-yourself practices are forbidden** and can cause hazards to people and the environment.



- **Substitute the old heating systems**, which generate **more polluting emissions**, particulate matter (PM10) and benzo[a]pyrene, carcinogenic substance, with **high-efficiency heating systems** that have at least four stars*.
